Chief Jenkins reported we are nearing the end of fiscal year. We have a lot of special projects for CWPP and will be using up the \$45,000 balance by month's end. The apparatus fund balance is at \$319,000; we received a check from the volunteer association for a contribution to the purchase of the Cozad trailer for \$15,000 which will reflect in next month's financials.

Director Southard moved and Director Taylor seconded the motion to approve the claims as presented.

2. Resolution 9-23 approving the 2023-2024 preliminary budget

Chief Jenkins reported the preliminary budget was reviewed by the subcommittee. Tax revenue is pretty consistent but will trend upwards due to a few new developments. The JPA numbers increased 3% and extra help by \$20,000. Workers comp will be discussed further. The apparatus beginning balance includes the \$15,000 from the volunteer association. The JPA has outstanding invoices and the Chief will meet with Chief Turbeville to close out all expenses by the end of the fiscal year. We will tighten up those numbers at final budget. President Pigoni reported we will clean up the JPA invoicing process with the agreement and will discuss at the subcommittee/ad hoc level. President Pigoni has reviewed the preliminary budget and supports it as presented.

Director Southard moved and Director Taylor seconded the motion to approve the 2023-2024 Preliminary Budget as presented.

- 1. President's Report Continuing with FASIS on the consolidation. There will be a report going out this week to districts.
- 2. Fire Chief's Reports (including subcommittee reports for budget, apparatus, building & liaison) Chief Jenkins reported Peter Avansino has been promoted to CalFire Battalion Chief for South Lake County. We are very proud of him! Way to go Pete! The weed abatement program is under way. It will be a challenging season due to late rains. Vegetation management projects will be continuing on Ranch House Drive to Hot Springs and the River Park on the city side. We will be running the masticator at the River Park next week. Our labor group for the Cloverdale employees submitted a letter to the board and chiefs that all but one Cloverdale employee decided not to join 1401 and that they will be a separate bargaining unit. The group is working on a date for a meet and confer. The zone held a mini MADD Drill. The Chief and Director Taylor reviewed the FSWAG presentation regarding the sales tax initiative. The presentation had old information for Cloverdale. The presentation show about 3% for Cloverdale of all Sonoma county sales tax collected. The plan is to standardize wages throughout the county.
