3. Resolution 05-24 approving the amendment to the employment agreement with the Administrative Assistant.

Chief Jenkins reported the amendment will include a \$450 per month contribution to a type of health savings plan until the employee turns 65 when Medicare kicks in.

1. President's Report – President Pigoni was asked to meet with the Northern Sonoma County Fire Protection District subcommittee for the 5-year strategic plan.. They had asked for 2 representatives from the Cloverdale Board to be involved with their committee. They have adopted their strategic planning framework. President Pigoni spoke to Chief Jenkins and has a recommendation that before we become an integral part of their plan, that we should establish our own framework rather than work from theirs. President Pigoni recommends that after the first of the year we should establish our goals and plans for the framework of the strategic plan and then meet with Northern Sonoma County Fire Protection District committee to point out any gaps and changes. The committee was very appreciative of President Pigoni's experience and would

- recommend that sometime in 2024 we begin this process. Thank you from the Chief to President Pigoni for the opportunity to address our interests for the strategic plan.
- 2. Fire Chief's Reports (including subcommittee reports for budget, apparatus, building & liaison) We had 3 members participate in the volunteer firefighter academy at the Junior College. There are 2 housing developments going vertical on the south end of town. We are making sure to keep the projects on track and make sure fire protection is in place prior to going vertical. We have been busy on the prevention side with DSI inspections which are almost complete..• We plan to present the CalFire dispatch contract to you next month. There are a lot of things going on with dispatch in the county right now and a lot of political issues are being worked out. Training Driver/Operator 1A & 1B class was held in Geyserville. Wildland focus training is complete and then our training will move into structure training and swift water rescue. The county-wide sales tax campaign will begin in January. Captain Sauder has taken a position with Piedmont Fire. We wish him well. Ernie is hoping to be back in December. We are still working on a plan to fill the Captain position.
